President's Message: Jerry Walsh, 29th pledge class, UD Class of 1987

Dear Brothers,

Another academic school year has finished and what a year it was! We accomplished many things this year and will accomplish much more next year!

We had a great turnout in March for the A-10 basketball tournament in Atlantic City. I was unable to attend the actual tournament. However, due to our fundraising ability for the University of Dayton (UD), I was invited to a pre-tournament gathering with the UD athletic director and Dr. Dan Curran (UD President).

Trip DeGroff and Bill Fajardo accompanied me and we had planned to speak with Dr. Curran about our fraternity's disappointment about Alpha Nu Omega being forced to go national. Unfortunately, Dr. Curran did not show up because he was sick. We were able to speak to Debra Reed, Vice President for the Office of Advancement. We explained to her that our fraternity is very involved and dedicated to raising funds for the UD through the Col. Paul Kelly Scholarship Fund. However, if we are forced to go national, the funds would probably cease to continue for obvious reasons.

Trip and Bill did a fantastic job explaining our goals to Ms. Reed and she was very receptive. Ms. Reed told us that the university has recently adopted a plan to raise over \$300 million dollars for UD and they need all the help they can get.

I sincerely believe that if we continue to support UD through our scholarship, they will continue to work with us in order to maintain a local fraternity.

With that said, Founding Father Marty Malloy, Fraternity Advisor Dr. Bryan Bardine, and current President of Alpha Nu Omega Patrick Morrison, met with the new Director and Assistant Dean of Students, Ms. Sarah Schoper. The informal meeting was used to discuss the future of Alpha Nu Omega. Marty sent out a detailed letter to everyone in early March summarizing the meeting.

Basically, the university has plans to eliminate local fraternities from campus and Sarah Schoper has been tasked with enacting and enforcing the plan. Later that same month, I flew to Dayton and Marty and I met with Sarah Schoper again, to confirm our assessment of this new plan.

This plan to will force Alpha Nu Omega and all other local fraternities to go national has been around for many years, but now UD is taking steps to make it active. Sarah Schoper stated that they have begun transitioning the Greek Council and IFC into a governing body. Ms. Schoper believes this will all improve Greek life on campus by having "the best standards of practice" that national fraternities offer.

Marty and I explained to Ms. Schoper that having a strong alumni association would be a better alternative to going national because we have many dependable, supportive alumni to give direction to the active brothers and to act as a governing body. We also mentioned that our alumni association would be willing to purchase a liability insurance policy to further demonstrate that we are serious about protecting UD from lawsuits. We also reiterated the fact that the Alpha Nu Omega Alumni Association has no intention of supporting the idea of taking our fraternity national.

Ms. Schoper understood the fact that we do not want to discard our history and traditions in order to accommodate the university's notion that national fraternities provide better support for the members of Greek life than do local fraternities. Ms. Schoper promised that she would talk to her superiors to see if purchasing insurance and staying local was a viable option.

Brothers, I also want to let you know that we have done plenty of research about going national. I have personally spoken to many national Greek organizations and in doing so, have concluded that I would not consider joining a national Greek organization and lose our legacy.

All we can do now is wait it out. If we are allowed to continue as a local fraternity, we will most likely be required to purchase liability insurance. If we purchase this policy, it will cost approximately \$6,000 per year. The plan will be to eventually shift this expense off to the active brothers, but right now, they do not have the numbers to support this expense. The alumni treasury currently has approximately \$3,000, so I will need your help to raise the remaining \$3,000. Annual membership due have not been collected for 2010 yet, so I am asking that loyal Alpha Nu Omega alumni contribute by paying your dues as soon as possible or purchase a car raffle ticket instead.

We are also in need of your tax deductable donations for the Col. Paul Kelly Scholarship Fund. In order for you to pay your dues or make a tax deductible donation or buy a raffle ticket for a 2010 Toyota Camrey or Prius simple and easy, I've included the link to our secure PayPal account.
